

**“\$225,000 CASH” KEYWORD SWEEPSTAKES
OFFICIAL RULES**

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Listeners accessing Sponsor’s radio station audio via IP connections like website-based streaming or mobile devices are welcome to enter. Employees of Cox Radio, Inc. 3. **How to Enter.** The Sweepstakes will begin at 7:59 a.m. Eastern Time (“E.T.”) on April 15, 2019 and end at 4:15 p.m. E.T. on May 17, 2019 (the “Sweepstakes Period”). Sponsor will be the official timekeeper for the Sweepstakes.

During each Listen Time for each weekday during the Sweepstakes Period, a unique keyword will be announced (“Keyword”). **In the event your Station is not announcing Keywords during certain days of the Sweepstakes Period, you may listen to any other Station during the relevant Listen Time to hear the Keyword and enter as set forth below.**

You understand that consent is not required to make a purchase. If these three (3) attempts go unanswered, Sponsor may select an alternate potential Winner from remaining Entries received during the applicable Listen Time. There will be a total of five (5) winners announced each weekday, and a total of one hundred twenty-five (125) drawings, during the Sweepstakes Period. Odds of winning will depend on the total number of eligible Entries received for a given Listen Time.

5. **Prize Description.**

There will be a total of one hundred twenty-five (125) winners announced during the Sweepstakes Period. Subject to verification of eligibility and compliance with these Official Rules, the potential winners will win the following prizes based on the weekday such potential winner was selected:

- Each potential winner selected on any weekday Tuesday through Friday during the Sweepstakes Period (April 16– May 17, 2019) will receive a check for one thousand dollars (\$1,000);
- Each potential winner selected on any Monday during the Sweepstakes Period (April 15, April 22, April 29, May 6, and May 13, 2019) will receive a check for five thousand dollars (\$5,000).

The total value of all prizes awarded under this Sweepstakes is two-hundred twenty-five thousand dollars (\$225,000).

6. **Winner Notification and Acceptance.** Sponsor will make three (3) attempts to call each potential winner, within fifteen (15) minutes of the conclusion of each text deadline (by 8:30 a.m. ET, 10:30 a.m. ET, 12:30 p.m. ET, 2:30 p.m. ET and 4:30 p.m. ET). If these three (3) attempts go unanswered, Sponsor may select an alternate potential Winner from remaining Entries received during the applicable Listen Time. Sponsor will not accept return phone calls. Potential Winners must answer their phone when contacted, in order to be a verified potential Winner. To claim his/her prize, the potential winner must personally visit the Station in his/her listening area within forty-eight (48) hours after notification (office visits must be between the hours of 9:00 a.m. ET and 5:00 p.m. ET, weekdays) and must present a valid government-issued photo ID. At that time, the potential winners may also be required to complete an affidavit of eligibility, and a liability and publicity release (except where prohibited by law).
